Dear schools and colleges,

This is a letter from West Midlands Police to let you know about the new ninja sword legislation and surrender scheme.

New laws come into force on 1 August, effectively outlawing ninja swords.

Before the new laws are enforced, a national Surrender and Compensation Scheme will run from 30 June to 31 July 2025.

The surrender scheme will allow people to hand in knives that fall within the new legislation at police stations, in return for an application for compensation. The legislation outlaws the manufacture, supply, sale, possession and importation of ninja swords, from 1 August 2025.

The new legislation is commonly known as Ronan's Law, named in memory of Ronan Kanda who was tragically murdered in Wolverhampton in June 2022. His killers used a ninja sword to inflict his injuries and as a result, Ronan's family have campaigned tirelessly since his death to change the law around the possession and sale of knives, especially ninja swords.

We want to reassure you that West Midlands Police officers are working round the clock to keep everyone safe and are on hand to deliver knife crime inputs to your pupils and students.

We think it is unlikely that one of your pupils will ask you about the scheme, but some pupils might already know and want to print off a compensation form at school. It's important to let pupils know that they should not bring knives or weapons into school. A list of police stations open to the public are listed on the second page of this letter.

We have included some helpful advice below around disposing of knives and how to talk to them about knife crime.

## How to have a conversation about knife crime with your pupils:

- 1. Find a quiet and comfortable time to chat.
- 2. They might be reluctant to talk to you. So, use a recent news event as a conversation starter.
- 3. Discuss knives and how you both feel about them being used you're there to listen and support them.
- 4. Tell them even when they feel they don't have choices, they do.
- 5. Explain that knives do not give protection. Carrying one could bring a prison sentence or risk getting hurt yourself.



- 6. Say the bravest thing to do is walk away from a dangerous situation.
- 7. Explore excuses for your students to walk away, e.g., picking up a little brother from school, running errands for their family, meeting a mate, or attending a sports club.
- 8. Reassure them that most people do not carry knives.

#### How we are protecting young people:

A number of initiatives are underway across local communities to tackle knife and weapon related crime.

Some examples are:

- Police and community-led weapons sweeps in parks and open spaces. This aims to recover weapons hidden for use in offences.
- Test purchase operations and responsible retailer visits to ensure stores are complying with the law on the sale of knives.
- A strong focus on the identification, arrest and management of offenders who use knives.
- Proactive police operations within key locations in the community to identify and tackle weapon related crime.
- School and college engagement to ensure students are informed of the law, risks and consequences of carrying knives. This is being supported within secondary schools and colleges with the delivery of random knife bar searches.

### What to do if you are concerned about a young person:

Speak to them calmly and explain the risks and consequences of carrying a knife.

You may wish to contact a member of the Pastoral Team at school if you feel your child isn't listening or is at risk. You can reach out your school's officers to seek advice. They can talk through your concerns and plan a way forward together.

Anyone can dispose of a knife discreetly and anonymously at a <u>weapon surrender bin</u>. If you or your students are aware that other young people in school or the community are carrying weapons, you should contact the police directly on 999 (emergency) or 101 (non-emergency). If a crime is taking place or a life is in danger, call 999 immediately. Alternatively, you can contact Crimestoppers anonymously on 0800 555 111 or via www.crimestoppers-uk.org

## Summary of the Surrender and Compensation Scheme for 'ninja' swords

The Criminal Justice Act 1988 (Offensive Weapons) (Amendment, Surrender and Compensation) Order 2025 adds ninja swords to the list of prohibited offensive weapons to which section 141 of the Criminal Justice Act 1988 apply. Link to the list of prohibited offensive weapons can be found here: <u>www.legislation.gov.uk/uksi/1988/2019</u>.

The Surrender and Compensation arrangements, set out in this guidance will only apply in England and Wales in respect of ninja swords prohibited under Part 3 of the Order.

If you currently possess a ninja sword, you will not be permitted to keep it once the relevant provisions in the Order are commenced on 1<sup>st</sup> August 2025 unless a specific legal defence applies. If you wish to claim compensation when you surrender the item, you must surrender it to a designated police station. The Surrender and Compensation scheme allows you to claim compensation if you meet the eligibility criteria and make a claim in line with the arrangements set out in this guidance and the Criminal Justice Act 1988 (Offensive Weapons) (Amendment, Surrender and Compensation) Order 2025.

If you are claiming compensation for a ninja sword, you must have been the lawful owner of or have contracted to acquire it on or before the cut-off date of **27 March 2025** and you will need to provide acceptable proof such as, a purchase receipt or invoice. If you are unable to provide a purchase receipt or invoice, you must provide some form of evidence of ownership and an explanation of what you are providing.

The standard compensation amount for each surrendered weapon will be £5, however applicants will be able to claim the value of their weapon if it exceeds this amount. To claim a higher value applicants will need to provide evidence of the value such as a receipt, invoice or other evidence of the value of the weapon.

Claims for compensation must be made at the same time as surrendering the weapon.

If you wish to hand in a ninja sword without claiming compensation or visiting a police station, you may also anonymously dispose of a sword in a surrender bin without completing the claim form or providing any details. Further guidance for alternative arrangements of disposing of your ninja sword will be published in a separate document before the Surrender scheme starts.

If you are the owner of a ninja sword, it is your responsibility to ensure that you transport it safely to a surrender bin or a designated police station and surrender it to the police and, if seeking financial compensation, submit your claim so <u>at the same time</u> as surrendering your item(s).

It will not be possible to seek compensation at any time after you have surrendered your item, or at any time after the surrender and compensation scheme closes. **The scheme will start on 1<sup>st</sup> July 2025, 00:00hrs and close on 31<sup>st</sup> July 2025 at 23:59hrs.** 

## Which items will become prohibited?

(u) the weapon sometimes known as a "ninja sword"

being a sword with—

- a blade whose length is at least 14 inches, but no more than 24 inches (the length of the blade being the straight-line distance from the top of the handle to the tip of the blade),
- (ii) a primary straight cutting edge,
- (iii) a secondary straight cutting edge,
- (iv) a blunt spine, and
- (v) either a tanto style point or a reversed tanto style point.

For the purposes of paragraph 1(u)(iv) and this paragraph, a spine is blunt if it is not adapted to cutting.

For the purposes of paragraph 1(u)(v)— a sword has a tanto style point if—

- (i) the angle between its primary straight cutting edge and its secondary straight cutting edge is greater than 90 degrees, and
- (ii) the angle between its secondary straight cutting edge and its spine is less than 90 degrees.

A sword has a reversed tanto style point if-

- (i) the angle between its primary straight cutting edge and its secondary straight cutting edge is less than 90 degrees, and
- (ii) the angle between its secondary straight cutting edge and its spine is greater than 90 degrees.

For the purposes of paragraph 1(u)(ii) and (iii) and this paragraph—

(a) a primary straight cutting edge is the longest cutting edge of a blade which immediately connects to the handle.

(b) a secondary straight cutting edge is a cutting edge—

(i) which forms an angle with the primary straight cutting edge and the spine, and (ii) is no more than 5% longer or shorter than the width of the blade immediately after the handle.

## Will you have to surrender your item(s)?

Once the provisions in the Criminal Justice Act 1988 (Offensive Weapons) (Amendment, Surrender and Compensation) Order 2025 come into force, it will be an offence to possess a ninja sword unless a specific legal defence applies. The manufacture, importation, sale and supply of these items will also be prohibited. However, before they are prohibited, the Order allows for legal owners of the items to surrender them at a designated police station and claim compensation for their loss if they wish. This guidance sets out how to surrender the item(s) to the police and how to claim compensation. Compensation can only be claimed if you were the lawful owner or contracted to acquire it on or before the cut-off date of **27 March 2025.** Owners who do not wish to claim compensation and who have no lawful basis to retain the sword will need to dispose of them responsibly before the legislation comes in to force in order to avoid committing an offence.

## What is the surrender period?

This is a one-month period (31 days) during which you will be able to surrender your ninja swords at a designated police station. Compensation can only be claimed if you surrender your item(s) during the surrender period and submit a claim for compensation at a designated police station at the same time.

## When will the surrender period start?

The surrender period will start on 1st July 2025,00:00hrs the day that Part 4 the Surrender of the Criminal Justice Act 1988 (Offensive Weapons) (Amendment, Surrender and Compensation) (England and Wales) Order 2025 comes into force, as this order will provide the legal framework for the compensation for items surrendered.

## When will the surrender period end?

The surrender period will last for a one-month period (31 days), ending on 31st July 2025 at 23:59hrs.

## What to do if you own a Ninja Sword(s)

These arrangements in respect of ninja swords apply only in England and Wales. If you own an item which falls under the definition of a ninja sword as described in the legislation, you will be able to surrender this item(s) at a designated police station and claim compensation. You must transport your item safely according to the guidance below. You can find your nearest designated police station by checking the gov.uk website or by contacting your local police force. In order to claim compensation, you will need to download the <u>claim form</u> from gov.uk and complete the **Ninja Sword Surrender and Compensation Scheme Claim Form** and hand this over to the police when you surrender the item(s). You must provide proof of purchase or other evidence to prove you possessed or had contracted to acquire the item before the cut-off date'. **Further detail is provided in section 1.** 

If you want to dispose of a ninja sword without claiming compensation or without going to a police station, we will also be providing alternative arrangements. Further guidance will be published in a separate document.

# What happens if you do not surrender an item during the surrender period?

Once the surrender period comes to an end on 31<sup>st</sup> July 2025, 23:59hrs ninja swords will be prohibited. If you are still in possession of the items at this point, your possession will become unlawful unless you have a defence. Once the surrender scheme closes, you will still be able to surrender the items to the police or dispose of a sword in a surrender bin, but you will not be able to claim compensation for the loss of the item.

# Do you need to complete a surrender and compensation scheme claim form if you are not seeking compensation?

If you are not seeking compensation, but are surrendering an item, we request that you only complete Part D to indicate you are not seeking compensation on the **Ninja Sword Surrender and Compensation Scheme Claim Form** without any personal and bank details and submit this to the police when you are surrendering your item(s). Details of how to access the form are found <u>here</u>.

## What to do if you have any special requirements or accessibility needs.

If you have any special requirements or accessibility needs that might impact your ability to surrender your item(s) you should contact your local police force to discuss.

# What to do if you think your Ninja Swords falls under one of the defences provided in the legislation?

Antiques are exempt from the effect of the Order, and it is therefore not an offence to possess these weapons if they are an antique – manufactured more than 100 years before the date that the offence is committed relating to s141 – Criminal Justice Act 1988.

You are not required to surrender your weapon(s) if it falls under one of the defences. In the event you are charged with an offence, you will need to provide evidence to support the defence you are relying on. Ultimately, it will be for a court to decide whether there is sufficient evidence to support your argument that you have a defence.

## Defences

Defences are listed in s141 Criminal Justice Act 1988 and the Criminal Justice Act 1988 (Offensive Weapons) Order 1988. Not all defences apply to all items, and it should be noted that the defences for religious reasons that applies to curved swords <u>do not</u> apply to ninja swords. The detail set out below is a summary and includes the full wording of the defences may be found in the relevant legislation:

S141 Criminal Justice Act 1988

Criminal Justice Act 1988 (Offensive Weapons) Order 1988.

- (i) Where possession is for the purposes of functions carried out on behalf of the Crown or of a visiting force.
- (ii) Where the weapon is one of historical importance.
- (iii) Where it is in a person's possession in their capacity as the operator of, or as a person acting on behalf of, a museum or gallery.
- (iv) Where possession is for educational purposes only.
- (v) Where possession is for the purpose only of making the weapon available for the purposes of theatrical performances and the production of films and television programmes.
- (vi) Where possession is for the purposes only of making the weapon available for, or participating in, a permitted activity i.e., a historical reenactment or sporting activity.
- (vii) Where the weapon was made by hand.
- (viii) Where the weapon in question is blunt.

# **1.Eligibility**

To be eligible to apply for compensation, you must have been the lawful owner on or before the cut-off date of **27 March 2025** and you will need to provide acceptable proof such as, a purchase receipt or invoice. If you are unable to provide a purchase receipt or invoice, you must provide some form of evidence of ownership and an explanation of what you are providing. You will also need to sign Part F - Declaration of the claim form confirming that you are the legal owner of the item and that it was lawfully acquired, when completing the **Ninja Sword Surrender and Compensation Scheme Claim Form.** 

You must surrender the item(s) to the police during the surrender period, in accordance with this guidance. The scheme will start on 1st July 2025, 00:00hrs and close on 31st July 2025 at 23:59hrs.

Compensation is sought by submitting to the police a completed **Ninja Sword Surrender and Compensation Scheme Claim Form.** This must be completed in advance and handed to the police, with any supporting documentation, at the time of the surrender. **Further detail is provided in section 4.** 

## 2.Entitlement (level of compensation payable)

The standard compensation amount for each surrendered weapon will be £5, though applicants will be able to claim the value of their weapon if it exceeds this amount. This is the minimum amount of compensation that the Home Office will pay to the legal owners of items that are surrendered to a designated police station under this scheme. If you consider that your item is worth more than the level of compensation set out, you will need to provide proof of purchase (e.g., purchase receipt or invoice) or other evidence of the value of the weapon which must be submitted at the time of surrendering the item to the police. This

evidence will then be forwarded to the Home Office for consideration. **Further details are provided in** <u>Section 5</u>.

No compensation will be payable in respect of a claim unless you were the lawful owner on or before the cut-off date of **27 March 2025.** 

## 3.How to surrender

During the one-month (31 days) surrender period, you will be able to surrender your weapon(s) to a designated police station. You can find out your nearest designated police station by checking the gov.uk website.

If you are a retailer or member of the public who intends to surrender several items at one time (more than 10 items). **You must contact the designated police station** in advance to see whether the police would prefer you to make a specific appointment to attend the police station. You should comply with the police directive of how to package and seal large consignments.

You must take all reasonable steps to make any item(s) that you are surrendering safe to handle whilst travelling to the police station and whilst on police premises. Items should be made safe to handle for yourself and for the police and must be contained in a manner that allows them to be transported without causing distress or alarm to other members of the public, including members of the public who might be at the designated police station.

Items must be wrapped up and placed in a sealed bag or box. **They must not be carried openly at any time.** Carrying bladed articles in public without a good reason or lawful authority is an offence. Carrying the items according to these instructions and accompanied by the claim form will allow you to claim that you have a 'good reason,' namely that you are about to surrender the articles at your nearest designated police station, if stopped by the police.

Once in the police station, you must not take out the item until you are requested to do so by a police officer or member of police staff.

If you want to dispose of a ninja sword without claiming compensation and attending a designated police station, further guidance on alternative arrangements will be published ahead of the surrender and compensation period.

## 4. How to claim compensation

You must submit your claim form, including evidence you have been the lawful owner of the weapon or contracted to acquire it on or before the cut-off date of 27 March 2025 and proof of purchase such as, a purchase receipt, invoice or other evidence of the value of the weapon to the police at the same time you surrender items at a designated police station; claims for compensation submitted at a different time or on a later date will not be accepted.

You will also need to bring with you evidence to confirm your identity (such as a valid passport or driving licence) and, where possible, evidence to establish that you are the legal owner of the item(s) that you are surrendering. If it is difficult for the legal owner to attend a police station and you are surrendering items on their behalf, you must bring evidence to confirm their identity, their consent for you to surrender the item and, where available, evidence of proof of purchase of the item(s).

The police will take steps to verify your ownership and eligibility under the scheme, including verifying that the item you are surrendering is one covered under the scheme. The police will then take possession of the item(s) and provide you with a copy of your claim form as a receipt if you are seeking compensation. The receipt provides you with a unique reference number in relation to the item(s) you surrender for the purposes of tracking the compensation claim. You must keep this unique reference number safe, as it may be required later if the Home Office contact you about your claim.

Your compensation claim form and supporting documentations will then be forwarded by the police to the Home Office where it will be considered. The Home Office will contact you once the claim has been considered.

Even though the police have accepted your surrendered item(s) and compensation claim form, it does not necessary guarantee that you will receive compensation. Your claim will be considered by the Home Office.

The Checklists provided at Annex B is for members of the public with less than 10 items and Annex C is for retailers and members of the public with more than 10 items. This may help you to ensure that you have completed all the steps needed to successfully surrender your item(s).

## 5.What happens next?

If you are surrendering an item or items, but you are not seeking compensation, once the police have taken possession of your item(s) or used a surrender bin the surrender process is completed. Your item(s) will be disposed of under normal police operational procedures.

If you are surrendering an item or items and are seeking compensation, once the police have taken possession of your item(s) they will retain the item(s) until your claim for compensation has been determined, unless that item poses a safety risk. Once determined the item(s) will be disposed of under normal police operational procedures or where it poses a safety risk it may need to be destroyed sooner.

If you have surrendered an item and it is determined that the item does not fall into the ninja sword definition and it is not prohibited by other legislation which can be found here: <u>www.legislation.gov.uk/uksi/1988/2019</u>, the police should return your item to you or will contact you to arrange the return of your item. If you no longer wish to keep the item, you may instruct the police to dispose of the item.

If you have surrendered an item and you are seeking compensation and have indicated this on the **Ninja Sword Claim Form**, your form and supporting documentation submitted to the police, will be forwarded by the police to the Home Office where it will be considered.

If for any reason it is determined that you are not eligible for compensation, you will be notified of this together with the reasons for the decision.

If the Home Office needs to contact you in relation to your claim, for example to clarify details on the form or to discuss the evidence of value that you have submitted, they will use the contact details you have provided on your claim form.



## Annex A: Types of Ninja Swords




\*Note a tanto style point has angle of greater than 90 degrees between its primary straight cutting edge and its secondary straight cutting edge, and the angle between its secondary straight cutting edge and the blunt spine is an angle of less than 90 degrees.

In the this first photo with the protractor, the angle between the primary straight cutting edge and the secondary cutting edge is approximately 136 degrees (over 90 degrees).



In this second photo with the protractor, the angle between the secondary straight cutting edge and the blunt spine of the blade is approximately 47 degrees (under 90 degrees).

\*Note a reverse tanto style point has angle of less than 90 degrees between its primary straight cutting edge and its secondary straight cutting edge, and the angle between its secondary straight cutting edge and the blunt spine is an angle of more than 90 degrees. The measurements of the angles will be the reverse of those in the above pictures for the tanto style point.

## Examples of types of sword which will be prohibited by the legislation.

These are swords with blades between 14" and 24" a straight primary cutting edge, a straight secondary cutting edge and tanto style points.




## Examples of types of swords which are already prohibited by the zombie-style knife / machete legislation.

These two swords are already prohibited because they have a plain cutting edge, sharp pointed ends, blades over 8" in length and more than one hole in the blade and so fall under the definition of a prohibited item listed in (sa) and 1A in the Schedule to The Criminal Justice Act 1988 (Offensive Weapons) Order 1988 which prohibits zombie-style knives and zombie-style machetes.



## Example of type of sword which is already prohibited by the curved sword legislation.

Katana type swords are already prohibited and fall under the definition of a prohibited item listed in (r) in the Schedule to The Criminal Justice Act 1988 (Offensive Weapons) Order 1988.
